1. The rate quoted should be for one year from the date of acceptance of quotation.
2. The firm should be an authorized dealer to sell the items (They should enclose authorization letter -/certificate).
3. The firm should mention their GST number properly.
4. The firm should supply the items to Institute within the stipulated time as mentioned in the supply order.
5. Delay in supply of the Chemicals, Reagents and Glass wares Penalty shall be imposed as below  
For delay up to 5 days from the last date for supply 5% of the billed amount.  
For delay up to 6-10 days from the last date for supply 10% of the billed amount.  
For delay up to 11-15 days from the last date for supply 15% of the billed amount.  
For delay up to 16-20 days from the last date for supply 20% of the billed amount.  
For delay more than 21 days 25% of billed amount.
6. While supplying the items the firm has to submit the delivery challan for the items supplied and obtain the initial of the Biochemist/Pathologist for the items supplied within the stipulated time and produce the same to office on the same day.
7. The items should be supplied F.O.R institute.
8. The firm wholly responsible for the Reagents & Consumables damaged at the time of transportation & packing.
9. While using the chemicals, kits if any defect/damaged is found appropriate amount will be deducted in the bill and appropriate action will be taken in this regard.
10. The firm should deposit EMD money of Rs.25,000/- (Rupees Twenty Five Thousand only) along with the quotation by means of Demand Draft drawn on any nationalized bank favouring "NATIONAL INSTITUTE OF UNANI MEDICINE B'LORE" Payable at Bangalore.
11. After quoting the rate of discount if the firm fails to supply the items due reason what so ever the institute shall procure the items from outside/other agency and difference amount shall be deducted from the EMD/bill while making payment.
12. After opening of quotation an amount of Rs.50, 000/- be de posited as Security Deposited by the firms quoted highest rebate/ for discount for the items.
