

Author Guidelines

Copyright Transfer. A statement transferring copyright from the authors (or their employers, if they hold the copyright) will be required before the manuscript can be accepted for publication.

All the articles published in this journal are protected by copyright, which covers the exclusive rights to reproduce and distribute the article (e.g. as off prints), as well as all translation right. No material published in this journal may be reproduced photographically or stored on microfilm, in electronic databases, video disks, etc. without first obtaining written permission from the publisher. The use of general descriptive names, trade names, trademarks, in this publication, even if not specifically identified, does not imply that these names are not protected by the relevant laws and regulations.

Ethics in Animal and Clinical Investigations

In animal studies the experimental protocol must be approved by the institutional animal care and use committee, and a statement to that effect must be included. Investigation using experimental animals must contain a statement confirming the adherence of the research to the Principles of Laboratory Animal Care (NIH publication #85–23, revised in 1985).

Investigation involving human subjects should be in accordance with the Helsinki Declaration of 1975 (revised in 2008) and be approved by the institutional ethics committee or equivalent; and this should be stated in the “Methods” section. In studies involving human subjects, the patient's right to privacy should be considered and any form of identifying information should not be published unless this is necessary for scientific purposes and the patient gives written informed consent.

SUBMISSION

3.1 Scope of Journal: Original research work in the form of research paper, short communication, case report, field surveys, book review, could be submitted for consideration for publication. The intense review articles and commentaries on previously published article and letter to the editors are also accepted. If the commentary criticizes an article published in the journal, the authors of the original article will be given an opportunity to reply in the same issue in which the commentary is published.

3.2 Manuscript Submission: The prepared manuscript should be submitted only as attachment by **email to jresUnanimed@gmail.com** Manuscript should be accompanied with a covering letter cum full disclosure, signed by the corresponding author on behalf of all the authors that giving details of 1) the title of the manuscript; 2) a statement that the manuscript has not been previously published in part or whole (except in the form of an abstract, as part of a published lecture, review, or thesis) or is not under consideration for publication elsewhere in any language; 3) a statement that all authors have agreed to be so listed (to provide full and appropriate credit to all who contributed to the experimental data and their interpretation and discussion) and have seen and approved the manuscript and its submission to this journal; 4) a full postal address, telephone and fax numbers, and e-mail address for each author; 5) Conflict of interests: Any information regarding the potential conflict of interests related to various aspects such as financial support by commercial firms, etc... should be disclosed in manuscripts to help clarify this issue.

No charge will be levied on manuscripts submitted.

4. Publication Process

4.1 Manuscript Receipt: Upon the receipt of the manuscript, the Editorial Office will assign a code number, which is to be used in all subsequent correspondence.

4.2 Peer Review: All submissions fulfilling the journal's requirements (regarding the field, format, the English language, and scientific quality and significance) will be reviewed anonymously by three or more national and international referees, expert in the field, at least two of which are out of the editorial board members. The corresponding author could also suggest potential reviewers to the journal at the time of submission. However, the editorial board reserves the right to select or refuse to use the suggested potential reviewers.

4.3 Revision: If revision is required, the authors should amend and resubmit the manuscript within stated time. Resubmission after prescribed time may be considered as a new submission. If the revision is not satisfactory to the reviewers, the author may be asked to make a second revision. Articles acceptance will be conveyed via Email to the corresponding author.

4.4 Rejected Manuscripts: If a manuscript is not accepted, the authors will receive a decision letter that may or may not include the reviewers' comments.

4.5 Proofreading: The corresponding author of a manuscript to be published will receive proofs. Checking the proofs is solely the authors' responsibility. The publisher is not responsible for any errors not marked by the author on the proof. The proof must be returned to the Editorial Office within 7 days of receipt.

PREPARATION OF MANUSCRIPT

The manuscript should be written in clear and concise English. It should be prepared in accordance with the “*Uniform Requirements for Manuscripts Submission to Biomedical Journals*” proclaimed by the International Committee of Medical Journal Editors. Authors are responsible for all statements made in their work. The right is reserved to incorporate any changes deemed necessary by the Editorial Board to make contributions harmonize the editorial standards of the Journal.

The manuscript should be in MS Word 2003 (or later), format with double space (12 pt. New Times Roman), on one side of A4 size, and enumerated consecutively from the title page on right side corner. The entire article should be submitted as a single file. Use SI units and give equivalent SI units in parenthesis when the use of other units is unavoidable. Symbol and abbreviations should confirm standard guide line.

For information about the structure of the articles, the authors should read the instructions below. It is also suggested to refer to the latest issue of the journal.

Structure of Articles: The Articles should include title page, abstract, keywords, introduction, Materials and methods, results and discussion, acknowledgement, references, tables, figures, and legends. While there are no fixed limitations to the length of an article, authors are asked to write their manuscripts in a

clear and concise manner and to include only data crucial to arriving at their final conclusions. Word count for original research manuscripts should be not more than 4000 words and 6400 for review article.

Title Page: This should include *title, author(s)* (include last name followed by initial, department affiliation, and institution), running title (not more than 50 characters, including spaces), name, address telephone number, e. mail ID of author to whom correspondence and reprint requests should be addressed. Title should be concise functional, informative and typed in capital letter (14 pt.). Very short and crypted title is to be avoided as the word in title may be used by electronic search engine in future to identify and categories the articles.

Abstract: A structured abstract of about 300 words should follow the title page. Abstracts of randomized controlled trials (RCTs) should consist of six paragraphs, labeled Background, Objective, Design, setting, participants and interventions, Main outcome measures, Results, and Conclusion. Abstracts of original experimental research papers should consist of four paragraphs, labeled Objective, Methods, Results and Conclusion.

Keywords: For indexing purposes, each submitted article should include five to seven keywords, preferably chosen from the Medical Subject Headings (MESH).

Text: The text is usually divided into sections with headings such as Introduction, Materials and Methods, Results, Discussion and Conclusion. For reports of randomized controlled trials authors should refer to the CONSORT 2010 Statement, which can be found at <http://www.consort-statement.org>. Each main heading like **Introduction, Methodology, results** etc. should be typed in bold, first letter capital and flushed to the left side of the page.

Statistical Methods: Statistical methods should be described in sufficient detail to enable a knowledgeable reader to assess the appropriateness of the statistical analysis used. Statistical terms, abbreviations, and symbols must be defined, and computer software must be specified. Lacunae in observations, such as dropouts from the study, should be reported, and the *intend-to-treat* method or as *per protocol analysis* should be clearly mentioned.

Acknowledgment: Acknowledgment(s) may briefly include assistance from 1) contributors that do not warrant authorship, 2) technical help, and 3) material support, as well as 4) financial support such as a grant. Permission from the parties being acknowledged should be obtained and the responsibility for the same lies with the corresponding author.

References: The authors are responsible for the accuracy of the bibliographic information. References must be numbered consecutively in order of citation in the text. Identify references in text, tables, and legends by superscript of Arabic numerals in parentheses. Personal communications, unpublished data, including manuscripts submitted but not already-accepted for publication, may not be used as a reference. Periodical titles should be abbreviated according to the *Index Medicus*. List all of the authors (surname followed by initials), title of the article, name of the journal or book, year, volume (issue) and the first and last pages. Do not use "*et al*". References to web site, web pages or other electronic sources should include access date of the data. The style and punctuation of the references should conform to the following examples:

Tables: The Tables should provide *easier understanding* and not duplicate information already included in the text or figures. Number tables consecutively in the order of their first citation in the text and supply a brief title for each table. Abbreviations must be defined in notes. Identify statistical measures of variations, such as standard deviation and standard error of the mean. Tables must be self-explanatory. If data from another published source is used, permission and acknowledgement of the source is must.

Figures: Figures should be included only if they augment understandability of the text. Illustrations should be numbered as cited in the sequential order in the text. Figures should be professionally drawn or photographed will be accepted in TIFF or JPEG format with hard copy. Letters, numbers, and symbols on figures should be clear. Titles and detailed explanations should be given in the figure legend. Legends for figures should be printed out with Arabic numerals corresponding to the illustrations. Photomicrographs should have internal scale markers. Explain the internal scale and identify the method of staining and magnification of photomicrographs. Each hard copy of figure should have a label on the back, listing the figure number, title of manuscript, first author, and an arrow indicating the top. When symbols, arrows, numbers, or letters are used to identify parts of the illustrations, identify and explain each one clearly in the legend. Abbreviations must be explained.

If photographs of people are used, either the subjects must not be identifiable or written permission from the depicted individuals must be included. If a figure has been published, acknowledge the original source and submit written permission from the copyright holder to reproduce the material. Color photographs are welcome at no extra charge

Anti-Plagiarism Policy: Manuscripts must be devoid of any forms of plagiarism. They should also have appropriate citations to the related literature in the field.
