Appointments to the above posts will initially be made for **one year**, which may be further extended on mutual consent and based upon the performance of the incumbent. The institute, however, reserves the right of termination of services of the appointee forthwith or before the expiry of stipulated period without assigning any reason. The Terms of Reference for the above posts are as follows:

#### **Name of Post : Program Associate**

**Essential Qualifications:** MD Unani from recognized university. Preference will be given to persons having working experience in Central Sector Schemes in AYUSH / Health sector. Working knowledge of MS Office, MS Word, MS Power Point and MS Excel, MS access would be essential.

#### **Responsibilities:**

- To coordinate & liaison with the nodal officers of the Peripheral Pharmacovigilance Centres (PPvCs); and stakeholders for smooth implementation of the program.
- To update and provide regular status reports of the program as desired.
- To assist in organizing the training programmes under the scheme.
- Other related activities assigned time to time.

### **Other Conditions:**

- Six days in a week work schedule will be applicable
- The assignment is on a full time basis and he / she has to ensure to attend the office on all working days and on holidays, if required on account of exigencies of work for which no additional remuneration will be paid.
- The appointee is required to give an undertaking to the effect that he / she will obey all the rules and condition of the Institute during the period of service.

**Salary:** Consolidated salary of ` 40000/- ( Forty Thousands only) per month.

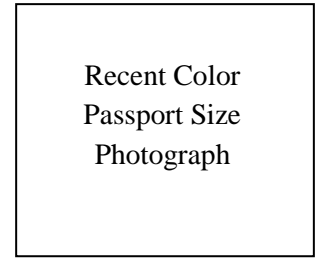
