or

(ii) 8 years regular service in a post in PB-3 and GP of Rs.7600 as Professor/Reader/Associate Professor **or** equivalent /corresponding pay scales as applicable to the post.

1. Administrative experience in the field of Unani System of Medicine in Central/State Government/Autonomous Bodies.
 2. Ph.D in Unani Medicine; and
 3. Publications of original articles in peer reviewed journals/books on Unani system of medicine.

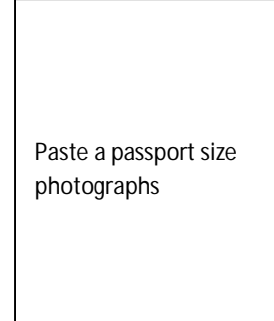
